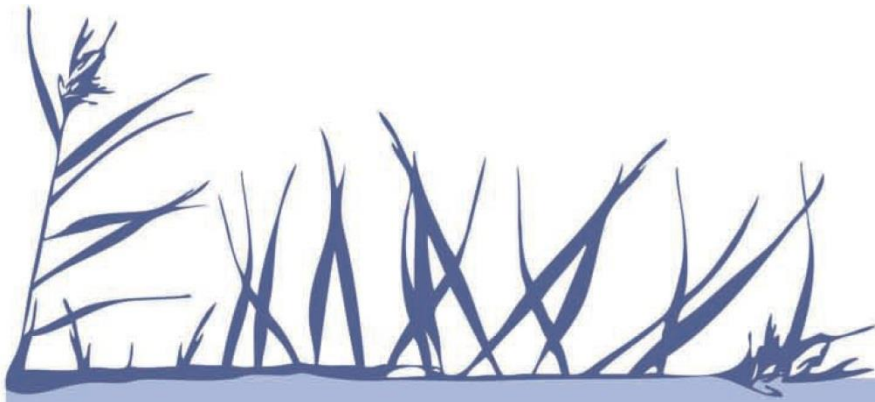

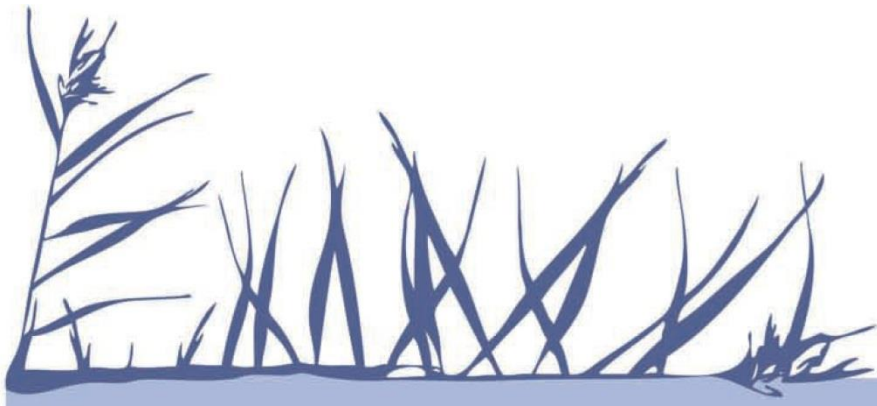

### **What does on-reserve matrimonial real property law mean to Musqueam?**

Resolution of this issue is long overdue. Government bodies at all levels have consistently recommended legislative action.

Provincial laws protect the matrimonial real property interests and rights of both spouses during a relationship, or in the event of separation, divorce or death. However, *on-reserve* matrimonial interests or rights include a couple's family home and other matrimonial interests or rights, where either spouses or common-law partners live together.

In 1986, the Supreme Court of Canada ruled that courts cannot apply provincial family laws on reserves governed by the *Indian Act*, if doing so would alter individual interests in matrimonial real property on reserves.

- Many of the legal protections relating to matrimonial interests or rights that are applicable off reserves are not available to individuals on reserves; and
- The *Indian Act* is silent on this issue.

Through the 2012 ratification of the Musqueam Land Code, Musqueam Band Members voted to manage our own land and resources.

This means we are now in a position to make our own law on matrimonial real property. We need your input on this important issue.

## ***Nepal's Indigenous Communities After the 2015 Earthquakes***

In April and May 2015, the Himalayan country of Nepal experienced two massive earthquakes. These devastating quakes were centred in territories that are home to many of Nepal's over 60 Indigenous nationalities. Over 9,000 people were killed, and 600,000 homes were destroyed.

This talk draws upon Mark and Sara's long-term collaborative partnerships with Indigenous communities who were deeply affected by the disaster. They will provide some historical and political context for understanding the experiences of Indigenous communities in Nepal, and then share some reflections about Indigenous responses to the challenges that the earthquakes have brought, and their environmental, economic, and political aftershocks.

**Sara Shneiderman** is an Assistant Professor in Anthropology and the Institute of Asian Research at UBC. She is the author of *Rituals of Ethnicity: Thangmi Identities Between Nepal and India* (University of Pennsylvania Press, 2015).

**Mark Turin** is an Associate Professor in Anthropology and serves as Chair of the First Nations and Endangered Languages Program at UBC. He has lived and worked in the Himalayas, where he has been involved in community-directed language documentation and revitalization initiatives.

#### **Summary**

The Musqueam Indian Band (MIB) has developed and is implementing an energy strategy that will include MIB interests and direction regarding the review and development of large energy related projects within the MIB territory. The Musqueam Energy Projects Analyst is a new position providing technical support to the Musqueam Energy Coordinator and to the Musqueam Fisheries Department, Intergovernmental Affairs, and Treaty Lands and Resources Department. The Energy Projects Analyst (Analyst) will work closely with staff and MIB contractors to implement the MIB Energy Strategy, which will include collaboration with partners, community engagement and MIB leadership. The Analyst will report directly to the MIB Energy Projects Coordinator, and or the MIB Band Manager as required.

#### **Role and Responsibilities**

The Analyst will be responsible for:

- Reviewing relevant energy related referrals and consultation requests being proposed to MIB
- Assist with conducting research and analysis for negotiations with the Crown and energy project companies
- Provide analysis support during negotiations between MIB, the Crown and energy project proponents (e.g. WesPac, FortisBC, BC Hydro, Woodfibre LNG, Kinder Morgan, etc.)
- Work closely with MIB technical staff to ensure leadership and community members are properly informed about energy related projects
- Assist with implementing the MIB Energy Strategy to ensure alignment with other MIB initiatives and plans (i.e. CCP, AHRP, etc.)
- Ensure energy related referrals are properly entered into the MIB Stewardship Portal (i.e. web-based referrals tool)
- Assist with community engagement sessions, including preparing presentation materials and newsletters
- Assist with reporting on energy projects (work plans, budgets, implementing strategies, etc.)
- Other related tasks as required

### **Position Summary:**

Reporting to the Housing Manager, the Housing Equalization and Administration Assistant (HEAA) assists in the administration of the Housing Program at the Musqueam Indian Band. The HEAA administers goods and services contracts required to maintain MIB owned housing; is responsible for ensuring quality products and services are being provided to the Musqueam Indian Band members; provides day-to-day field supervision of the Program's works and in charge of tenant relations.

### **Duties:**

- Greets clients and visitors and directs them to the appropriate contacts or services;
- Answers, screens and forwards telephone calls, takes messages and provides information to clients and visitors as required;
- Processes Equalization Program Repair requests; answers questions and provides information regarding the Equalization Program to the Musqueam Indian Band members; researches and verifies information as requested;
- Maintaining and administering the Musqueam Equalization Program;
- Maintaining all approved document templates are processed to the master document binder;
- Maintains and administers replacement reserve fund;
- Resolves administrative concerns by coordinating preparation of reports, analyzing data, and identifying solutions;
- Maintains and upkeeps the Emergency binder;
- Maintains and updates housing rent and equalization spreadsheet;
- Ensures housing department maintains front desk coverage;
- Works in collaboration with Housing Executive Assistant to ensure that Data Entry for Asset Management is complete and up to date;

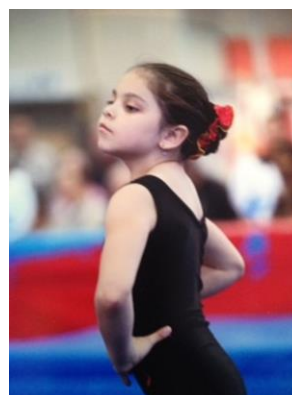
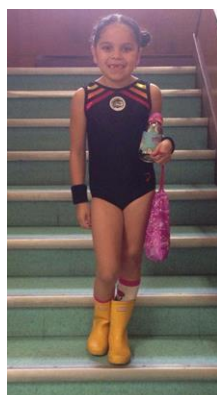
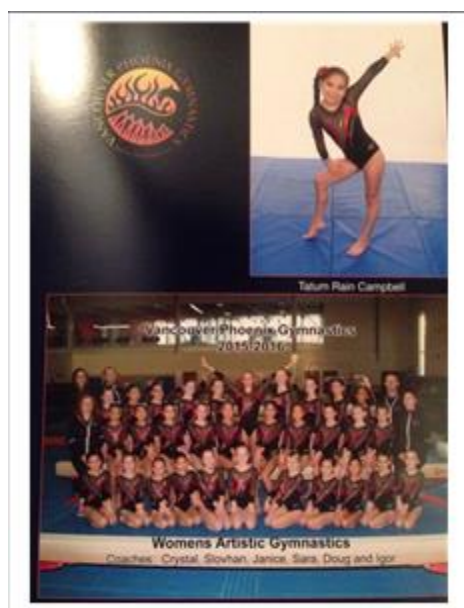
### VANCOUVER PHEONIX GYMNASTICS WAG COMPETETIVE DIVISION
