### ***Representations of Coast Salish communities in early German Anthropology***

In German institutions there are collections of Salish cultures that have rarely been seen. Join us for an evening with Rainer Hatoum who will share knowledge about these treasures. Salish communities came to the “attention” of the newly established field of Anthropology in the late 1800s. Among these early anthropologists was German born scholar, Franz Boas. There were also people working for anthropological institutions in Germany such as Adrian Jacobsen who collected for the Museum of Anthropology in Berlin. Their work resulted in representations of, and reflections on Salish culture and language in Germany and/or in German.

Dr. Rainer Hatoum is from Goethe University, Frankfurt. From 2005 to 2012 he worked at and with the Berlin Museum of Anthropology and the Free University in Berlin. He explored the potentials for building lasting partnerships between German museums and different native communities in North America on the basis of existing collections. After deciphering the shorthand of Franz Boas 2012/2013, the ground was paved for his current research and book project on the subject of Boas’ field notes.

Just a friendly reminder, please make an appointment with Leanne or Renee to renew your application for the new fiscal period.

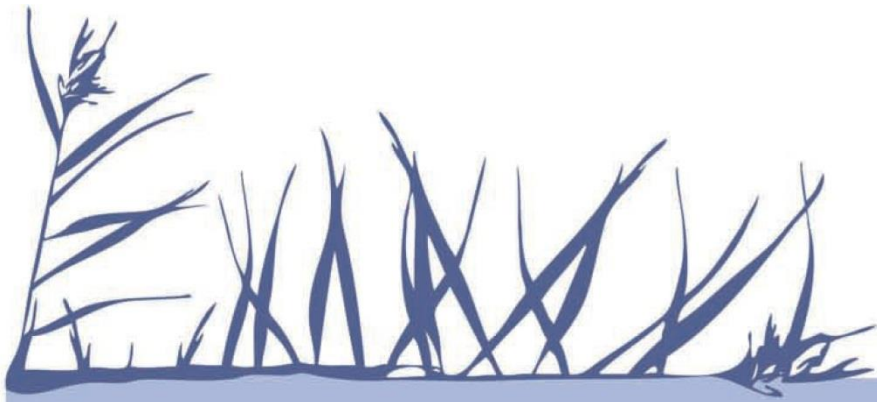
Each adult must have two pieces of ID, one (1) picture and one (1) piece for each child.

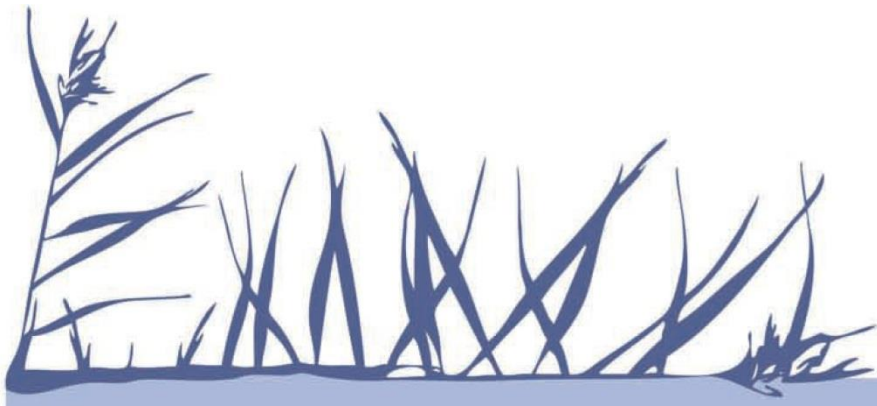

### **What does on-reserve matrimonial real property law mean to Musqueam?**

Resolution of this issue is long overdue. Government bodies at all levels have consistently recommended legislative action.

Provincial laws protect the matrimonial real property interests and rights of both spouses during a relationship, or in the event of separation, divorce or death. However, *on-reserve* matrimonial interests or rights include a couple's family home and other matrimonial interests or rights, where either spouses or common-law partners live together.

In 1986, the Supreme Court of Canada ruled that courts cannot apply provincial family laws on reserves governed by the *Indian Act*, if doing so would alter individual interests in matrimonial real property on reserves.

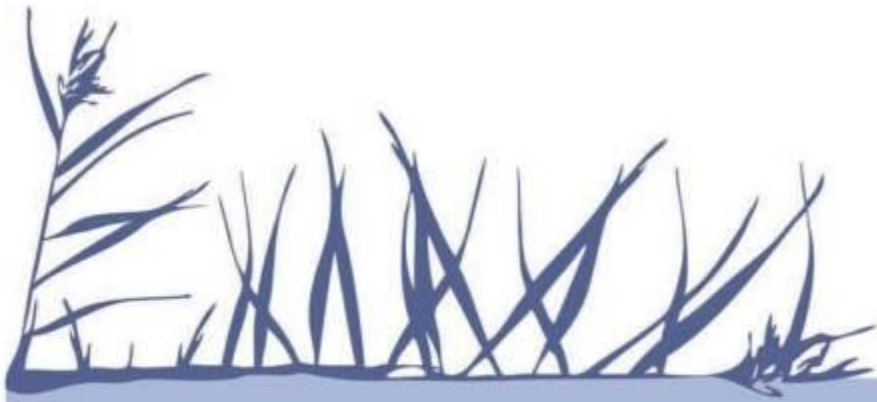
- Many of the legal protections relating to matrimonial interests or rights that are applicable off reserves are not available to individuals on reserves; and
- The *Indian Act* is silent on this issue.

Through the 2012 ratification of the Musqueam Land Code, Musqueam Band Members voted to manage our own land and resources.

This means we are now in a position to make our own law on matrimonial real property. We need your input on this important issue.

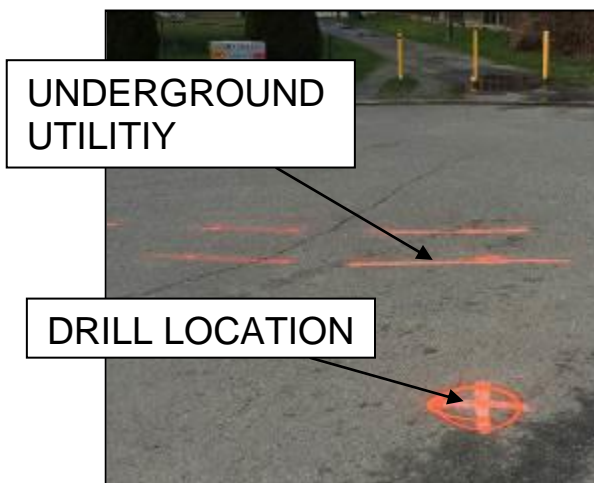

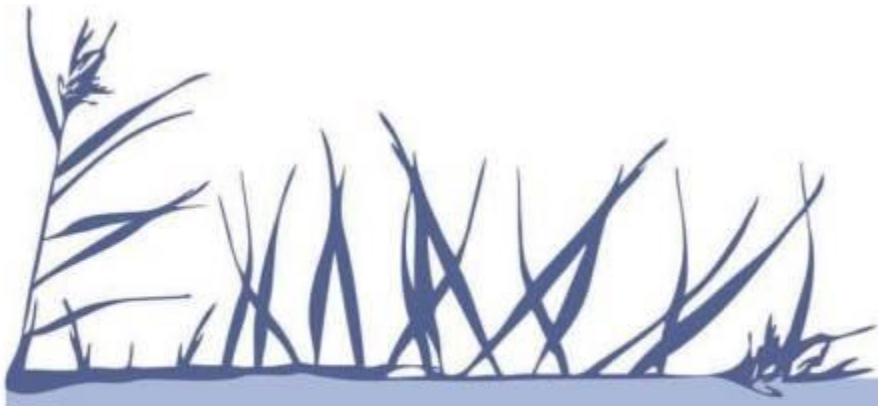

#### Ground Gas Monitoring Well Installation – Drilling and Hydrovac Truck

On behalf of the Musqueam Band, Teranis Consulting and Blue Max Drilling will be working in the community to install ground gas monitoring wells to assess potential presence of underground gas production (e.g. methane).

A utility locator person may have made markings on your property (dashed lines in orange spray paint) to show where underground utilities (e.g. electrical, gas, water lines) exist. Also, an orange circle may be marked on your property, showing the drill location. Please ensure that the drill locations are accessible for the drilling equipment on the days identified above (PLEASE DO NOT PARK ON/OR BLOCK DRILL LOCATIONS).

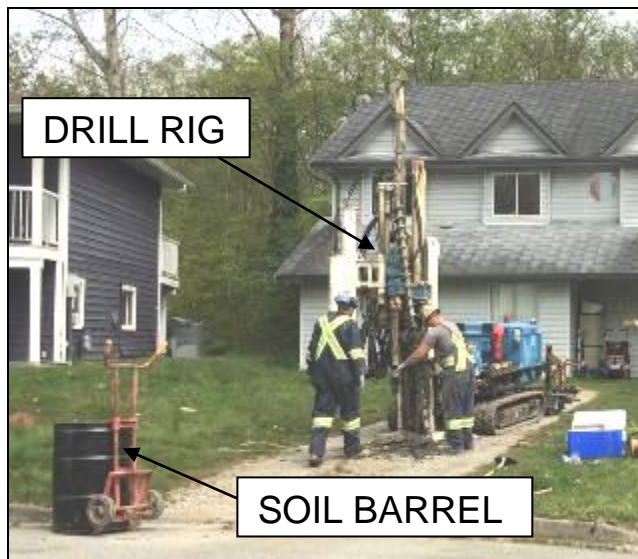

## THE HONOURABLE JODY WILSON-RAYBOULD

Jody Wilson-Raybould is a lawyer, advocate, and leader among British Columbia's First Nations. As a former Regional Chief of the BC Assembly of First Nations, Jody brings extensive experience in law, public service, and First Nations governance to Cabinet.

After being called to the Bar in 2000, Jody began her legal career working as a provincial crown prosecutor in Vancouver. She later served as an advisor at the BC Treaty Commission, a body established to oversee treaty negotiations between First Nations and the Crown. In

2004, Jody was elected as Commissioner by the Chiefs of the First Nations Summit.

Since being elected Regional Chief of the BC Assembly of First Nations in 2009, Jody has devoted herself to the advancement of First Nations governance, fair access to land and resources, as well as improved education and health care services.

An active volunteer in her community, Jody has served as a Director for a number of organizations. She is the recipient of the alumni award from the Minerva Foundation and the University of Victoria.

Jody is a descendant of the Musgamagw Tsawataineuk and Laich-Kwil-Tach peoples, which are part of the Kwakwaka'wakw and also known as the Kwak'waka speaking peoples. She is a member of the We Wai Kai Nation and is married to Dr. Tim Raybould.

## **INTRODUCTION**

**On behalf of the University of British Columbia and the Musqueam Indian Band, UBC Ceremonies is seeking proposals from Musqueam artist(s) to design and create a cultural addition for the UBC Chancellor's and President's regalia, which is worn at all the graduation ceremonies (32) at the Vancouver campus.**

The University and Musqueam Indian Band are seeking an experienced, talented Musqueam Nation artist(s) interested in creating this cultural addition, which will enhance the current academic regalia and acknowledge that UBC is located on the unceded traditional territory of the Musqueam.

## **SCOPE OF WORK**

To design and create a cultural addition that would signify the relationship between Musqueam and UBC.

The addition should complement the existing regalia and also meet the following design requirements:

- Gender neutral
- Size neutral
- To be worn on the upper body, so it will be visible when wearers are at the podium
- To be worn on the existing regalia , not worn on the head
- Designed to be worn, not carried
- Visible in photographs

When designing the item and choosing the material, the artist should take into consideration the wearer will be under hot stage lighting for the majority of time they are in the academic regalia.

## **PROJECT GOALS**

The goals of the project are to:

- Provide visible recognition of the relationship with Musqueam and an acknowledgement of the Vancouver campus location on the traditional unceded territory of Musqueam.
- Be part of the celebration of UBC's Centennial and specifically the May 2016 Centennial graduation ceremonies.
- Complete the items by May 1, 2016, to be presented on stage to both the Chancellor and President at the first ceremony on May 25, 2015.

## **BUDGET**

The budget for the artist(s) is \$750 per piece, including time, materials, and any minor reasonable revisions as requested by the Joint Musqueam – UBC Selection Committee.



## **CONTENT OF PROPOSAL**

The artist shall submit the following:

- Written resume of the Artist;
- Samples of previous work, submitted as hard copies or as digital images (emailed or on a flash drive);
- Names and contact information of three references;
- Written outline of the Artist's concept for and description of the Cultural addition (not to exceed 500 words) including the Artist's approach to this project
- Clearly labeled sketches, pictures, photographs and/or renderings of the proposed cultural addition to the regalia.

## **PROCESS**

The final selection will be made by a Selection Committee composed of representatives from the University of British Columbia, and Musqueam. The Selection Committee's decision is final and binding.

Factors that will be taken into account in the selection process will be:

- The Artist's previous experience, previous works and capacity to personally produce the proposed design as a final product
- Creativity and relevance of the cultural addition to the academic regalia, relating it to the ceremonial significance of the wearing of the regalia and the importance of the event to students and their families.
- An artists briefing can be arranged if requested
- The artist(s) selected may be requested to have photographs taken while working on the selected design, and to be present at a presentation ceremony.

The Selection Committee reserves the right to reject any and/or all submissions and proposals, to alter, extend, terminate or postpone this RFP for any or no reason and to issue a new request for proposal or negotiate directly with one or more Artists.

In order to be formally engaged to produce the cultural addition, the artist selected by the Selection Committee will enter into a legally binding agreement with UBC that sets out:

- The schedule for completion;
- Delivery and installation particulars;
- The compensation to be paid and the copyright therein;
- The assignment by the artist of all copyright of the cultural addition to UBC, and
- The waiver of the artist's moral rights to the cultural addition, in favour of UBC.

## **ON-GOING MAINTENANCE**

UBC will assume responsibility for the budget associated with the on-going care of the cultural addition.

Proposals may be hand delivered, sent by courier or emailed. All proposals must be received at the address below by **12 noon on February 29, 2016.**
